## Evidence of Net Income (after deductions)

To be eligible for free school meals, your families' annual household income must be no higher than the following:

- £22,700 for families outside of London with one child
- £26,300 for families outside of London with two or more children
- £31,200 for families within London with one child
- £34,800 for families within London with two or more children

This includes any wider income or support you may be receiving in addition to any earnings from employment. **You will need to provide documentary evidence as proof of your income for both yourself and partner (where applicable)** – this could be a bank statement, a pay slip or an employment contract.

**In addition to these thresholds, families must hold no more than £16,000 in capital and savings.**

If your visa changes or your earnings rise above the threshold you must inform us and your child's school of your change in circumstances.
