FURTHER INFORMATION AND HOW TO APPLY FOR FREE SCHOOL MEALS – 2026/27

Further Information:

Children under the compulsory school age who are in full time, state-maintained nursery education (nurseries that are based at a Primary School) may also be able to get free school meals.

For applicants who have NRPF (No Recourse to Public Funds):

Targeted and Expanded Free School Meals:

From the start of the 2026 to 2027 Academic Year, there will be 2 categories of eligibility for Free School Meals:

Eligible Targeted:

Eligibility Criteria:

- Children in households in receipt of Universal Credit, with annual household earnings of £7,400 or less
- Households in support under Part VI of the Immigration and Asylum Act 1999
- Households in receipt of income-related Employment and Support Allowance
- Households that receive the guaranteed element of Pension Credit

These children will attract Pupil Premium and other disadvantage funding for their schools. Other education entitlements, such as the Holiday Activities and Food program (HAF) and the 'extended rights' element of School Transport Assistance will be based on the **Targeted** Free School Meals.

Eligible Expanded: this covers children who are in households receiving Universal Credit with annual household earnings exceeding £7,400. Children will be entitled to Free School Meals only.

How to Apply:

1. Complete the application form fully and provide **all** the information we have asked for so that we can carry out a benefit check. You **do not** have to send in evidence of the benefits you receive unless we ask you to.
2. Please email your completed form to: fsm@bcpcouncil.gov.uk.

When we receive your completed application:

- We will check your benefit entitlement with data held by the Department of Work and Pensions, the Home Office and HMRC (Revenue and Customs) through a central Eligibility Checking Engine (ECE). If we cannot confirm your entitlement through this process, we will write to you to ask you to provide up-to-date evidence of the benefits you receive.
- We will confirm your Free School Meals eligibility by email, and we will confirm whether you are eligible under Targeted or Expanded, and what level of support you are entitled to. If you have not provided an email address, we will write to the address that you have used on this application.
- We will inform your child's school of your child's Free School Meals eligibility.
